## **GRINDING SERVICES SPECIFICATIONS**

Brush, leaves, limbs and other organic materials are currently collected at the OEMA Landfill located at 20435 SW 29th Street, Union City, OK 73090 and the Mustang Collection location located at 540 W. SW 59<sup>th</sup> Street, Mustang, OK 73064. Periodically this material will require to be ground or chipped. We are expecting to require services twice a year, however depending on volume, this may increase.

The contractor shall furnish all labor, equipment and material required to grind material. OEMA and contractor will monitor and track the cubic yards of brush and debris.

Contractors will have access to the site from 7:00 AM to 3:00 PM Monday through Friday excluding holidays.

All contractors bidding is requested to inspect the sites prior to bidding. Failure to inspect the site will not be grounds for withdrawal of bid.

Bidders must provide three (3) references of a similar nature.

OEMA cannot guarantee that the missed brush and wood collected will not contain metal.

OEMA and Contractor will schedule the services but must be within 30 days of requested service by OEMA.

Remains from grinding at Mustang location will need to be loaded into OEMA equipment for transport. Remains from Union City location will be remain onsite. No need for removal.

Subcontracting is not permitted.

Pricing will be submitted as an all-inclusive rate by cubic yard.

Insurance – Must provide an original ACORD form certificate of insurance outlining the minimum coverage set forth below with each proposal. Awarded Proposer's shall be required to supply OEMA an original standard ACORD form certificate of insurance naming OEMA as an additional insured with the following minimum insurance coverage:

- Workers' Compensation: Coverage to apply for all employees for Statutory Limits in compliance with the applicable state and federal laws.
- Comprehensive General Liability: Shall have minimum limits of \$1,000,000 Per Occurrence Combined Single Limit for Bodily Injury Liability and Property Damage Liability. This shall include premises and/or Operations.

### **CERTIFICATE OF NONDISCRIMINATION**

In connection with the performance of this contract, the vendor agrees as follows:

(A) Not to discriminate against any employee or applicant for employment because of race, creed, color, sex, age, national origin, or ancestry.
